NSPCC Learning

Listening to children and young people's experiences of disclosing child sexual abuse

A central recommendation from the Independent Inquiry for Child Sexual Abuse (IICSA, 2022)¹ was the introduction of a mandatory reporting duty in **England** and **Wales** for disclosures of child sexual abuse.

To help understand the potential implications of this proposal, the NSPCC commissioned researchers from the University of Bedfordshire to review the evidence on:

- the barriers to disclosure children and young people face
- the motivators and facilitators that help them to disclose sexual abuse
- their experiences following disclosure.

The review identifies a number of key insights to inform thinking on the proposed mandatory reporting duty. It also highlights gaps in the current research, including a lack of consideration of the reporting systems in place in the countries in which children disclosed abuse, and limited research into children's perspectives and experiences of those systems. The report recommends further direct research with children and young people to inform the design of any proposed system.

Statutory guidance

Early years foundation stage (EYFS) statutory framework

Summary of changes for group and school-based providers, since the previous issued framework. Updated 19th January 2024.	
Group and school-based settings must:	
\Rightarrow	ensure setting managers appointed on or after 4 January 2024 hold a level 2 maths qualification, or they achieve one within 2 years of starting in the position (Section 3, Staff:child ratios)
\Rightarrow	ensure your setting's safeguarding policies and procedures include all electronic devices with imaging and sharing capabilities, not just mobile phones and cameras (Section 3, Safeguarding policies and procedures)
⇒	ensure all level 2 and level 3 staff members who gained their qualification since June 2016, hold a valid paediatric first aid (PFA) certificate, otherwise they cannot be included in ratio (Section 3, Paediatric first aid)
Group and school-based settings may wish to consider applying the following flexibilities, if appropriate:	
\Rightarrow	level 3 practitioners in group and school-based settings will no longer be required to hold a level 2 maths qualification to count within staff: child ratios (Section 3, Staff: child ratios)
⇒	a manager in group and school-based settings can now allow students and apprentices to count in staff:child ratios at the level below their level of study, if the manager is satisfied that they are competent and responsible (Section 3, Staff: child ratios)
⇒	settings may provide opportunities for children to develop and use their home language in play and learning, previously this requirement stated this 'must' be done (Section 1, English as an Additional Language)
Group and school-based settings should also be aware that the following updates have been made to the EYFS:	
\Rightarrow	there is a new statutory document on early years qualification requirements and standards
\Rightarrow	the language has been changed to clarify that physical evidence does not need to be collected for assessments (Section 2, Assessment)
⇒	a clarification made that while qualifications must be verified, employees do not have to provide physical copies of their qualifications (Section 3, Suitable people)

⇒ a clarification made on the wording on the validity of paediatric first aid (PFA) certificates (Section 3, Paediatric first aid)





There is a new free tool called CyberSecure Check for Schools, which has been developed by SWGfL for the Department for Education (DfE) and it officially launched at the end of December. This innovative new tool will help support schools with their cybersecurity practices and support policy development. CyberSecure Check for Schools works very similarly to our award-winning online safety self-review tool 360Safe, providing schools with a framework to self-assess against and work towards improvement.

What is CyberSecure Check for Schools? CyberSecure Check for Schools is a comprehensive tool designed to assist schools in reviewing and enhancing their cyber and information security policies and practices. This tool is particularly relevant in the context of the increasing volume of cyber-attacks, such as ransomware, which has posed significant risks towards the education sector over many years. Here's an in-depth look at CyberSecure Check for Schools:

- 1. How Does it Work?: CyberSecure Check for Schools is a free self-assessment tool specifically for schools. It is designed to help school leaders be proactive and better informed about their institution's cyber resilience. The tool allows schools to self-assess their current cyber and information security provisions, providing a structure to categorise safety and security levels, ranging from level 0 (most basic) to level 5 (most aspirational).
- 2. How Do I Navigate It?: The tool is organised into elements, strands, and aspects, with each aspect featuring six level statements. Users can select a rating from 0 to 5 for each aspect, with 5 indicating the highest level of achievement. The review dashboard offers an overview of progress, including a radar graph that shows selected levels for each aspect, the current national level, and recommended benchmark levels. This structure facilitates an instant assessment of areas needing improvement.
- 3. Who is This For?: CyberSecure Check for Schools is suitable for any school setting, including multi-academy trusts, and is beneficial regardless of the establishment's size. By using this tool, schools can work to strengthen their defenses against cyber-attacks. It is designed to be accessible to both experts and non-experts, offering guidance and action plans for improvement based on the current assessment. The tool also emphasises the importance of evaluating the risk posed by supply chain attacks, where trusted suppliers may inadvertently become conduits for cyber threats.
- 4. How Does it Help Us to Improve?: After selecting a level for each aspect, the tool presents relevant improvement actions. Users can enter commentary on their current position, provide evidence, and outline an action plan for enhancements. Progress in each aspect is calculated based on the selected level and the commentary entered.
