## Working Together to Safeguard Children 2023

A guide to multi-agency working to help, protect and promote the welfare of children

#### December 2023

You will have all seen that the government has published the revised version of Working Together to Safeguard Children following the consultation.

## Key points are:

- $\Rightarrow$  No statutory roles or functions have been removed
- ⇒ Increased emphasis on multi-agency working
- ⇒ Changes to the law included, eg: Domestic Violence Act 2021
- Greater emphasis on extra-familial harms and exploitation

## **Key Points:**

 $\Rightarrow$  The DfE has announced the expansion of the Virtual School's role which means that all carers of children under a Special Guardianship Order will be entitled to information and advice from the Virtual School, not just those who were previously in care. NAVHS welcome this announcement as it ends some of the inequality that currently exists

 $\Rightarrow$  The Virtual School's strategic responsibilities for children with a social worker will be expanded to include children in all kinship arrangements.

⇒ **£3.8 million** in additional funding has been announced to support this expansion

 $\Rightarrow$  These expanded duties come into effect from September 2024

 $\Rightarrow$  This guidance does not change the eligibility criteria for the pupil premium plus grant or the admissions code of practice in relation to priority admission categories. (I've included this as it is likely to be one of the FAQs arising)
